Dear friends!

For our organization, 2018 was a year that meant two decades of commitment and dedication to promoting children's rights, preventing child abuse and ensuring a protective environment

for all children in the country. The experience we gained and the lessons we learned gave us courage to proceed to a new stage in the organization's work, so that in 2018 we launched the Strategic Plan for the next 5 years. An ambitious document with large-scale objectives and outcomes that we take full responsibility for.

If we re-visit the work undertaken during the reporting year, we see that we have managed, through our actions, to influence important policies and practices in support of child victims of violence and, at the same time, we have provided child victims with access to specialized assistance services. Child abuse and neglect continue to be a serious violation of children's rights, and the attention and efforts of the NCCAP will continue to be directed with the same tenacity in the next period to ensure the right of the children to be protected from any form of violence. We thank all our supporters for their trust and support! Together we become stronger in preventing violence against children and giving girls and boys the chance to enjoy their childhood.

RESEARCH

Child sexual abuse remains a difficult topic to raise in a parent-child discussion

The topic of sexual abuse is still not widely discussed with children aged 5-11 in the Republic of Moldova. Only 4 in 10 parents of children aged 5-11 talk to children about the risks of sexual abuse. These are the findings of the comparative survey *"Assessment of attitudes of parents who have children aged 5-11 towards sexual abuse"* conducted in 2015 and 2018 by IMAS, commissioned by NCCAP and Empowering Children Foundation (Poland), with the support of OAK Foundation.

A similar study conducted in the same period in Poland shows a situation that is far from the realities of Moldova. There, 80% of parents said in 2018 that this topic was discussed with their 5-11-year-olds.

According to the results, the share of Moldovan parents who talk to their children about the risks of sexual abuse decreased by 5% compared to 2015. However, parents who talk to children feel more confident to initiate a discussion on this topic with children at younger ages (6 out of 10 parents), by 20% more compared to 2015. Mothers are considered the key persons responsible for educating children in this area - 67% of answers. The ranking is followed by fathers with 12%, while 6% believe that this role should be played primarily by the school.

The perceptions are erroneous regarding child abuse

Nine out of ten adults in the Republic of Moldova consider that it is necessary to report cases of child abuse to the state authorities, according to the Survey "*Opinions and perceptions about domestic violence and child abuse*", carried out in 2018 by CBS-AXA, commissioned by NCCAP, with the support of OAK Foundation. At the same time, 7 in 10 people consider that Moldovans do not report cases of abuse and most of them do not do so, because they are afraid of the abuser and do not believe that the authorities will solve the cases.

Verbal violence continues to be perceived as the most common form of child abuse in the Republic of Moldova, as compared to other types of violence (physical, sexual) and is also the most tolerated form of abuse.

Child sexual abuse is a more sensitive aspect for most adults -90.5% of respondents believe such cases should be reported regardless of the child's age. At the same time, at least 4 out of 10 people in Moldova have erroneous perceptions about the phenomenon of child sexual abuse:

17.5% of the population believe that child sexual abuse does not happen in our country, and 19.5% of respondents found it difficult to estimate how spread this phenomenon is..

RESEARCH

Being the parent of an adolescent involves as many challenges as adolescence itself

The qualitative sociological survey "Needs of the parents of adolescents for communicating, upbringing and disciplining them" highlighted a number of needs/difficulties of adolescents' parents: the communication on sensitive topics, particularly, puberty, love, sexuality (some of the parents said they did not even believe that their children might be in contact with a sexually transmitted disease); seeking the adolescent's opinion and his/her participation in decisionmaking; finding a balance between giving freedom and setting boundaries, especially, in relation to the use of information technologies; the influence of friends and professional guidance. The study was carried out within the project "Cultivating the teenager's engagement in family activities", implemented by NCCAP with the support of UNICEF Moldova.

ADVOCACY

For child-friendly justice

In collaboration with the Ministry of Justice (MoJ) and the General Police Inspectorate, we promoted the **draft Law on the organization of the interviewer's** work, which regulates the interviewer's status and role in the hearing of child victims/witnesses of crimes. The document encourages professionals to be interviewers, defines the institution responsible for managing the interviewers' work and its role in the inception and follow-up training. This project is necessary to ensure the quality of the hearing without revictimizing the child. In 2019 we will continue to work on this important project.

In order to launch the first Barnahustype service in our country, together with the Ministry of Health, Labor and Social Protection (MoHLSP), we developed the draft Regulation of the Regional Integrated Assistance Service for child victims/witnesses of crimes, the quality standards for this service, as well as its costing and financing mechanism. The establishment of this service allows child victims/witnesses of crimes to receive multidisciplinary assistance in the framework of the Regional Integrated Assistance Service for child victims/witnesses of crimes.



In partnership with MoJ, we developed the draft Standards for the accreditation of rooms for hearing under special conditions of child victims/witnesses of crimes. The standards will allow equipping all the hearing rooms according to international practices. Once the accreditation Standards are approved, the quality of the evidence collected from children's testimonies will be ensured, avoiding repeated hearings.

ADVOCACY

Prevention of violence against children

- In collaboration with the Ministry of Education, Culture and Research (MoECR), we were able to update the curriculum of the subject "Personal Development" for primary grades with a number of skills/content aimed at recognizing the signs of abuse, including sexual abuse, identifying and enforcing safety rules in potentially dangerous situations at or near the school, in the park, at the grocery store, on the street, at home or near home.
- As a result of the collaboration with the line ministry, the Standards for early education and the Curriculum for early education were approved and indicators aimed at protecting children from sexual abuse were included in these documents.

Monitoring violence against children using unified indicators

In collaboration with MoHLSP, we developed a set of unique indicators for collecting data on cases of child abuse identified and reported by the authorities. These indicators allow unifying the systems for the collection of data on cases of abuse, neglect, exploitation and trafficking of children, from the social protection, health, education and police systems. The unification of indicators and the accurate collection of data will allow us to have a full picture on violence against children at national level.

PREVENTION

The program for children - "On the way home"

About 2,900 YOUNG CHILDREN of school age, including children of refugees, were informed about the safety rules on their way home. The professionals created contexts in which children might experience personal efficiency, encouraging them to find solutions to potentially dangerous situations that might be encountered at school, on the street, in the park or at home independently. Thus, children improved their capabilities to identify situations of insecurity and threat in a playful manner.

Libraries - a protective space for children

Based on the partnership established with the "Novateca" Program, we managed to bring this program to children through several libraries in Hincesti, Leova and Cimislia districts. Thus, libraries managed to become a protective space for children and the librarians became resource people for both young users of library services, and for the system of primary protection of children-victims or potential victims.

The program for parents – "No smacking"

More than 1800 PARENTS learned how to handle their anger in difficult situations and how to set boundaries for the child with love and respect. Parents declared that after going through the program they became friendlier and thriftier with children, wiser and, as a result, the relations with children improved.





PREVENTION

Program for adolescents - 12PLUS

More than 500 ADOLESCENTS were informed and empowered to recognize risky sexual relationships such as sexting, sponsorship and child trafficking. The adolescents approached these types of relationships from the perspective of their motivation, the mechanisms of coercion/ manipulation used by the aggressors, the decision-making processes and the consequences of these relationships on physical and psycho-emotional health. Thousands of people were informed through the website <u>www.12plus.md</u> which

ASSISTANCE

The child and family psychosocial support service AMICUL

527 CHILD victims received direct services within the child and family psychosocial support service AMICUL. We included 311 new children-victims in the service, while other 216 children received follow-up assistance.

6 OUT OF 10 children and their families received social assistance focused on defining the type of abuse, determining the degree of danger to children's life and health, planning and carrying out specific interventions to provide a protective environment.

5 OUT OF 10 assisted children and their parents/caregivers received psychological assistance based on individual intervention programs aimed at reducing the consequences of abuse and at developing parental skills.

Out of the total number of child victims of crime in the country who were heard under special conditions, $4\ OUT\ OF\ 10$ were heard with the support of NCCAP.

For 42 CHILDREN taken into care in 2018, psychological evaluation reports were developed and used by the guardianship authorities, law institutions and other line institutions to demonstrate abuse and identify optimal solutions for child protection.

52 CHILD ABUSERS were convicted in the assisted cases, including due to the support we provided to children and courts of law in the framework of the legal proceedings.

CAPACITY BUILDING

Professionals trained for the establishment of the first Barnahus in the country

- More than 150 PROFESSIONALS, judges, psychologists, lawyers, doctors, public prosecutors, investigation officers, social workers and forensic pathologists were trained in the development of the first regional specialized Barnahus-type service for child victims/witnesses of crime.
- The first training in this regard was provided by the founder and author of the Barnahus Service in Iceland, Bragi
 Gudbrandsson, member of the Council of Europe's Committee for the implementation of the Lanzarote Convention, who came to Chisinau for this purpose.
- Another series of 5 trainings were supported by NCCAP trainers and addressed the specialized approach of the child within this type of Service, so that Barnahus provides a friendly and safe environment for children, bringing all relevant services under one roof.

The supervision of professionals - a reliable form of increasing efficiency in the assistance of child victims

Over 60 professionals (psychologists, psychiatrists and social workers) benefited from:

- 2 clinical supervisions with the participation of international experts the psychologist Pavel Kornienko (Russian Federation) and Sorina Petrica (Romania), that addressed the work with sexually abused children. The focus was on the specificity of work with the consequences of various types of psychological losses, the specifics of therapeutic work with the effects of sexual abuse and the primary reaction to loss.
- 2 clinical supervisions with the participation of national experts Parascovia Topada and Oxana Sevcenco (NCCAP), which addressed the most frequent difficulties in identifying and understanding atypical behaviors of children as indicators of sexual abuse and the defense mechanisms that are most commonly used by victims of sexual abuse.

AWARENESS-RAISING AND FUNDRAISING

The event of the year was the 2nd edition of the concert **"Be the hero of a child"** with the performance of the singer Vali Boghean, who became an advocate for the cause of abused children, and his Band. The most beautiful songs in the singer's repertoire and the touching lyrics created an atmosphere where love and empathy filled the air. Hundreds of people who came to the concert became aware of and contributed to the rehabilitation of abused children. The sale of tickets allowed raising 76,450 MDL. The event was conducted with the support of partners: Felicia Foundation, Dulcinella Chain, Radisson Blu Hotel, S. A. Bons Offices, CIO Film. The **Dodo toy -** the mascot of the abused children, as well as the coloring books where Dodo is the main hero, accompanied us to the public events we attended. On the eve of winter holidays, we launched a new Dodo product - the Dodo biscuits, which decorated Christmas in many families. The **Dodo products** reached 800 people, both in the country and abroad, including thanks to the partners: BERD's Design Hotel, Radisson Blu Hotel, Regency Hotel, "Panda Tur" Travel Agency, National Children's Library "Ion Creanga". Through the fundraising campaigns, we managed to collect funds that covered 2% of the annual budget of the organization.
